Letter of Continuing Guaranty: **SANI-T-10 PLUS**

Spartan Chemical Company, Inc., as the manufacturer of Sani-T-10 Plus, guarantees that this product is safe and effective for use in food processing plants, including USDA inspected facilities, when used as directed on the product labeling and this letter. When used in this manner this product will not adulterate food product or create unsanitary conditions.

Sani-T-10 Plus is a quaternary ammonium chloride based no-rinse sanitizer for food contact surfaces.

Sani-T-10 Plus:

- Is registered with the US EPA as Reg. No. 10324-117-5741
- Complies with 21 CFR Section 178.1010 "Sanitizing Solutions"
- Conforms to USDA's "Sanitation Performance Standards Compliance Guide, Appendix 2, Chemical Use" published 10/13/1999 by FSIS
- Meets the profile of USDA's former "D2" "Sanitizers for all surfaces not always requiring a rinse".
- Meets the profile of USDA's former "Q3" "Shell Egg Sanitizing Compound".
- Chemical evaluation and/or preservative challenge testing ensures product stability against microbial contamination (21 CFR§117.35 compliance).

Before using Sani-T-10 Plus, food products and packaging materials must be removed from the area or carefully protected. A potable water rinse is not required following the use of this product in official establishments, provided that the equipment and utensils are adequately drained before contact with food, so that little or no residue remains which can adulterate or have a deleterious effect on edible products.

Sani-T-10 Plus is acceptable as a sanitizing agent for shell eggs when incorporated into a warm potable water spray rinse for use in sanitizing clean or freshly washed eggs.. Eggs that have been sanitized with this quaternary ammonium compound shall be subjected to a thorough potable water rinse only if they are to be immediately broken for use in the manufacture of egg products. The sanitizing solution must not be reused for sanitizing eggs.

Carefully read and follow all statements on the labeling and Safety Data Sheet while using this product.

Food processing facilities must validate their processes and procedures to ensure compliance with applicable regulations.
